How many cigarette butts have your passengers, guests (and staff) littered today?

As our society has become more waste and energy conscious, Businesses, Councils and Organizations have made significant improvements in recycling practices, waste reduction and energy efficiency to minimize their impact on the environment.

However, until recently, cigarette butt litter, the world's largest environmental litter problem, has not received the same degree of attention. Cigarette butt litter outside buildings, and scattered by the billions across our cities and countryside has increased considerably since the introduction of indoor & vehicular smoking bans, and this litter rapidly enters our stormwater and aquatic systems - poisoning our environment, degrading its beauty and taking years to break down.

Cigarette butt litter at resorts, landmarks, tourist attractions and national parks is primarily created by tourists, and to a lesser extent by tourism industry staff & employees. They're the only ones who can actually reduce the problem of litter, but they need help to do it.

Butt litter responsibility provides the means for responsible business owners and Management to assess their efforts to provide adequate education and disposal infrastructure in order to reduce the cigarette butt litter emanating from their business activities.
