Terms and Conditions of Trading with No BuTTs Australia Pty. Ltd.

1. Payment terms for invoice price in full is strictly cash on delivery (COD) unless other trading terms are agreed to in writing by No BuTTs Australia Pty. Ltd.
2. No BuTTs Australia Pty. Ltd. invites applications for the approval and establishment of credit facilities, but reserves the right to withdraw said credit facilities without notice to customers deemed unreliable, or who fail to comply with the terms of credit set down below in item #3.
3. On written approval from No BuTTs Australia Pty. Ltd., credit terms are strictly payment in full within 14 days of Invoice Date. An active account fee of \$15.00 per month, (&/or fraction thereof) will apply to all accounts with outstanding balances.
4. No BuTTs Australia Pty. Ltd. may charge interest at three (3) per cent above the current Commonwealth Bank interest rate for overdrafts of \$100,000 on payments not received within trading terms.
5. Dates of delivery are anticipated only and No BuTTs Australia Pty.Ltd. accepts no liability for late or non-delivery for reasons beyond its control.
6. Products are at the risk of the buyer after collection from No BuTTs Australia Pty.Ltd. or upon delivery to address on invoice by No BuTTs Australia Pty.Ltd. or its agents. No BuTTs Australia Pty. Ltd. accepts no liability for the products after delivery.
7. Buyer shall have two (2) business days to report in writing to No BuTTs Australia Pty. Ltd. any defects. Otherwise buyer deemed to have accepted products. If any defects, products must be returned to No BuTTs Australia Pty. Ltd. after written notice to No BuTTs Australia Pty. Ltd. who shall replace the products (if No BuTTs Australia Pty. Ltd. agrees in its sole but reasonable discretion that a defect exists) as soon as possible. If after giving notice of defects to No BuTTs Australia Pty. Ltd. the buyer fails to return the products with defects within seven days, the buyer shall be deemed to have accepted them.
8. A defect will not be accepted by No BuTTs Australia Pty. Ltd. if products are tampered with by buyer or a third party. Returns will only be accepted with prior authorization from No BuTTs Australia Pty. Ltd., and are at the risk of the buyer.
9. Prices and packaging specifications are subject to change and may be varied by No BuTTs Australia Pty. Ltd. at any time.
10. Ownership of the products remains with No BuTTs Australia Pty. Ltd. until payment in full is made (together with any interest) and No BuTTs Australia Pty. Ltd. shall have and retain a lien over the products until payment in full is received.
11. It is the buyer's responsibility to insure products from the point of delivery.
12. No BuTTs Australia Pty. Ltd. reserves the right to cancel any order and/or delivery if the buyer has not paid No BuTTs Australia Pty. Ltd. for any previous products (and interest if applicable).
